Brief description of proposals

20mph zone to improve road safety and increase active travel

Chudleigh has many extremely narrow footpaths – often less than 1m in width – making social distancing impossible with two-way pedestrian flow and creating a (perception of) potential hazard from close passing. This is a highly problematic issue for all residents, but especially children, those with mobility issues, wheelchair users and those with sight or hearing impairments who are significantly less able to negotiate the available space safely.

As the number of pupils in schools increase and high street businesses reopen, pedestrian footfall will increase. Active travel needs to be prioritised. Road safety improvements are required to allow pedestrians to utilise road space and pavement space safely, to maintain social distance and allow two way flow. With 20 mph vehicular use, the walking/cycling experience will become safer to navigate, less noisy and and promote a healthier alternative to travelling through town (particularly when socially distancing on narrow streets with narrow pavements like we have in Chudleigh).

Ideally the proposed zone would be signed from the safe crossing point on New Exeter Street near Colway Lane and from the junction of Colway Lane and Old Exeter Street and run to the safe crossing point at the top of Oldway. (See Figure 1 attached). It should also include Market Way which is the entry/exit point to the car park, main supermarket (Coop), and the two Doctors Surgeries.

Highways England

In 2017, as part of the NDP, Highways England were consulted about the Public Realm Improvements that formed part of the NDP. This included a 20mph zone through the high street. They had no objections.

5.1.1 'The scheme has been discussed with DCC in their capacity as local Highways Authority. They are supportive of the principles of the scheme and the specific measure proposed. It was noted that DCC has delivered a similar scheme, known as Blundells 20mph zone in Tiverton'

5.1.2 'They agreed that traffic speed is an issue'

Chudleigh Town Council has undertaken a number of public consultations over the years in regard to the Town, and traffic speed has always been a priority.

Chudleigh Parish Plan

In 2009, the Chudleigh Parish Plan produced. The responses totalled circa 30% of the community. Recommendations were comprehensive and far reaching; two of the priorities for the town were identified as:

- Address traffic congestion and pedestrian safety
- · Town Centre improvements; trading, public realm and urban quality

Neighbourhood Development Plan

In 2016/17, as part of our public consultation for the Neighbourhood Development Plan, Chudleigh held 2 public consultations. Traffic was a major factor in the document, with 64% of responders feeling that slower speeds in town would attract them to use the Town Centre more.

From this consultation POLICY CHNDP15: TOWN CENTRE ENHANCEMENT was created:

- Measures to enable the safer crossing of the roads, especially in the vicinity of the War Memorial.
- Measures to reduce the volume and speed of traffic through the centre.

Parking removal to create safer bus stop and waiting area The westbound bus stop is currently allocated on the road forcing passengers to queue in a high footfall area outside the shops. The proposal is to remove parking allocation from the adjacent lay-by and reallocate it as the bus stop.
